Ashley Furniture occupies Distribution Center No. 4 at the park, an inventory building completed by ProLogis in the third quarter of 2005.

The Hodgdon companies have been working with Ashley for a decade on various real estate and construction projects. Hodgdon-Miank Construction completed major renovations this year for the opening of an Ashley Furniture HomeStore in the cities of Long Beach, Hawthorne, Fountain Valley and Yorba Linda, Calif.
